AMENDMENT TO THE BY-LAWS

The amendment of Article I, 1., 2. to the By-Laws approved by the Executive Council on April 12 is presented below. If one hundred Members and Graduate Student Associates do not protest in writing to the Executive Director within ninety days of the distribution of this Newsletter, the amendment will be written into the By-Laws. If one hundred members protest, a mail ballot will be required and will be carried out utilizing the next issue of the Newsletter.

Basically, the amendment removes the restrictions which now prevent nominating members for the Vice-Presidency or the Executive Council who have been nominated for such office during the previous three years, or who have served in an elective office in the past four years. At the same time, it prevents Executive Council members from being reelected until at least two years after the expiration of the prior term. The amendment reaffirms the desirability of maintaining the diversity in disciplines, geography, age, and sex in the membership of the Council.

By-Laws Now in Force

Article I. Nominations

1. The Nominations Committee annually shall make nominations for the Vice-Presidency and the Executive Council, and shall submit them to the membership six weeks prior to the formulation of the official ballot. Each nominee must have been a member in good standing of the Association for at least one year prior to her/his nomination. No one may be nominated who has been a nominee for any office during the previous three years. No one may be a nominee who has served in any elected office during the previous four years.

2. The Nominations Committee shall seek to assure the broadest possible representation on the Executive Council. To that end, in making nominations the Committee shall take into consideration the desirability of maintaining diversity in the following characteristics of members of the Council:

- a. Disciplines: The Committee shall seek to assure that at least four different disciplines are represented on the Executive Council at all times;
- b. Geography: The Committee shall seek to assure representation on the Executive Council from the various regions where members reside;
- c. Age and academic rank or its equivalent: The Committee shall seek to assure that younger Members are represented on the Executive Council at all times;
- d. Sex: The Committee shall seek to assure that women be represented among the nominees for the Executive Council at all times.
- e. At least ninety days before the Executive Council may take action on the appointment of the Nominating Committee, the membership of the entire Association shall be canvassed through the Association's Newsletter for suggested names of Nominating Committee members. In constituting the Nominating Committee the Executive Council shall endeavor to achieve some diversity of geographical region and discipline and by such other differentiations as may be judged appropriate by the Executive Council. Each Nominating Committee shall be assisted by the chair of the previous Nominating Committee.

Amendment

Article I. Nominations

1. The Nominations Committee annually shall make nominations for the Vice-Presidency and the Executive Council, and shall submit them to the membership six weeks prior to the formulation of the official ballot. Each nominee must have been a member in good standing of the Association for at least one year prior to her/his nomination.

2. The Nominations Committee shall seek to assure broad and diverse representation in the Association's governance. In seeking nominees for the Vice-Presidency, the Nominations Committee shall consider persons who have not previously held office in LASA as well as those with LASA administrative experience. Members of the Executive Council will not be eligible for nomination for reelection to the Council until at least two years after the expiration of the prior term. With regard to all nominations, the Committee shall take into consideration the desirability of maintaining diversity in the following characteristics of members of the Council:

- a. Disciplines: The Committee shall seek to assure that at least four different disciplines are represented on the Executive Council at all times;
- b. Geography: The Committee shall seek to assure representation on the Executive Council from the various regions where members reside;
- c. Age and academic rank or its equivalent: The Committee shall seek to assure that younger Members are represented on the Executive Council at all times;
- d. Sex: The Committee shall seek to assure that women be represented among the nominees for the Executive Council at all times;
- e. At least ninety days before the Executive Council may take action on the appointment of the Nominating Committee, the membership of the entire Association shall be canvassed through the Association's Newsletter for suggested names of Nominating Committee members. In constituting the Nominating Committee the Executive Council shall endeavor to achieve some diversity of geographical region and discipline and by such other differentiations as may be judged appropriate by the Executive Council. Each Nominating Committee shall be assisted by the chair of the previous Nominating Committee.

(Note: a., b., c., d., and e. have not been changed and are currently in force. They are repeated in the amendment for providing a complete presentation of how Article I, 1., 2. will read, if approved.)

LASA COMMITTEE NEWS

A LISTING OF LASA AND CLASP COMMITTEES AND THEIR MEMBERS IS AVAILABLE UPON REQUEST FROM THE SECRETARIAT. Oscar J. Martínez is chairperson of the Task Force on Hispanic Communities, replacing Jean Franco.

THE LASA TASK FORCE ON ACADEMIC FREEDOM AND HUMAN RIGHTS is in the process of establishing a network of academic institutions, research organizations, and individual Latin Americanists to identify and assist Latin American scholars who, as targets of political repression, are forced to leave their countries for reasons of personal safety. The purpose of this network is similar to that of the Emergency Committee to Aid Latin American Scholars (ECALAS), which functioned in the early and mid-1970s to find temporary employment and admission to graduate programs in the United States for threatened colleagues. Center directors, department heads, and LASA members who are interested in becoming involved in this effort should send their names to Lars Schoultz, Department of Political Science, Hamilton Hall, University of North Carolina, Chapel Hill, NC 27514.

THE MEDIA COVERAGE SUBCOMMITTEE announces that work from the mass media (news articles and television documentaries) selected for its excellence and impact by the Committee will be recognized at the Bloomington meeting and at future national meetings. Members wishing to make nominations of news articles should send the printed work along with their recommendations to the Committee. Nominations of TV documentaries must be accompanied by reviews and recommendations of at least four members in the area in which the work was shown. Nominations should be sent to Al Stepan, Latin American Studies, Yale University, Box 1970, New Haven, CT 06520, as soon as possible before September 15.

LASA is preparing a NATIONAL REGISTER OF HISPANIC AMERICAN AREA SPECIALISTS, which will be printed in late 1980. David Maciel chaired the committee in charge of this activity, following a recommendation made by the LASA Regional Hispanic Task Force at a meeting last November. NATIONAL MEETING BUSINESS SESSION PROCEDURES

LASA members who wish to propose a resolution or any other business for the National Meeting are referred to Article VI of the By-Laws governing national meetings and printed below:

Article VI. National Meeting

1. At each National Meeting there shall be a Business Session, during which only Members in good standing may vote. Such a vote at such a meeting shall be effective for any legislative purpose consistent with the Constitution and By-Laws of the Association. Neither the Constitution nor By-Laws can be amended at any such meeting. Unanimous consent from members present is required for non-members to be permitted to speak at the Business Session, but non-members may not make or second motions in any case.

2. The agenda for the Business Session shall include such committee reports and legislative business as the Executive Council may deem appropriate. Members in good standing who wish to propose additional items for the agenda must do so by mail to the Executive Director, postmarked at least fourteen days before the date of the National Meeting.

3. Any legislative action of the Members taken at a National Meeting shall be submitted to a mail ballot of all Members.

4. The proceedings of the National Meeting shall be governed by Robert's Rules of Order, newly revised.

5. A Quorum for the Business Session of the National Meeting shall consist of twenty percent of those members registered for the Meeting.

6. On each occasion for voting, the presiding officer shall call for three categories of preference: yeas, nays, and abstentions.

7. Resolutions for consideration at the National Meeting must be submitted in advance to the Executive Council and, if referred to the assembly and passed, must then go to a mail ballot before being reconsidered by the Executive Council. Resolutions on questions of academic freedom and human rights must first be referred to the Academic Freedom and Human Rights Task Force, which, after due study, will report its findings to the floor and recommend what action, if any, should be taken.

8. At business meetings, motions other than those dealing with procedural matters will be accepted only when they address unforeseen new events that preclude the use of normal resolution procedures. Such motions must be signed by five LASA members and presented in writing to the Executive Council at least 24 hours before the business meeting. The EC shall consider all such motions and recommend to the assembly what action, if any, might be taken.

INSTITUTIONAL NEWS

DR. JOSUÉ GONZÁLEZ was named DIRECTOR OF THE OFFICE OF BILINGUAL EDUCATION AND MINOR LANGUAGES AFFAIRS (OBEMLA) in the new Education Department (ED). González is presently director of the Office of Bilingual Education, a position he has held since October 1977. He was formerly Coordinator of Bilingual Chicano Studies and Assoc. Prof. of Education at Southern Methodist University. The new Education Department will take over most education programs currently in HEW and a limited number of education-related programs in several other agencies.

The COUNCIL ON LEARNING, New Rochelle, NY, is attempting to identify and evaluate U.S. college and university programs in international education. About 50 such programs will appear in a volume published by Change Magazine Press, along with results of the student survey and task force recommendations. Approximately 15 will be reported in depth on a special issue of Change on "Education and the World View."

The GREAT LAKES COLLEGES ASSOCIATION (GLCA) has announced a change in agent colleges for its Latin America Program in Bogotá. The Center for Latin American and Caribbean Studies at the UNIVERSITY OF ILLINOIS, URBANA-CHAMPAIGN, has awarded Tinker Foundation Field Research grants totalling \$31,200 to 21 scholars for 21 projects this summer. Of the total amount, \$15,000 comes from the Tinker Foundation and \$16,200 in matching funds from campus units throughout the University.
