



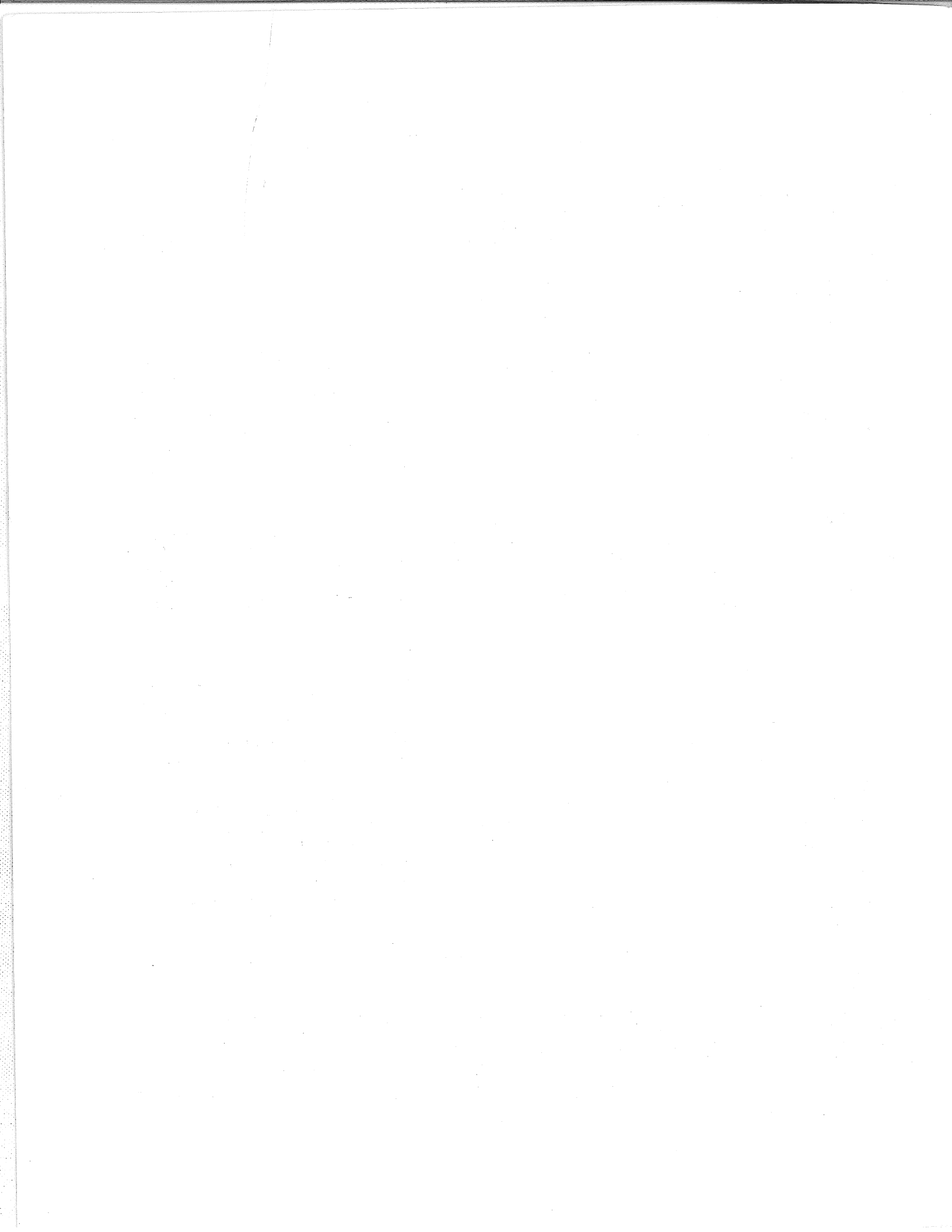

Your extreme enthusiasm has been contagious, and you have endeared yourself to many by your dedication to the needs of the LASA and CLASP constituencies. I have seen you function as a representative of LASA and CLASP to government and foundation groups, and I have always felt that we were in good hands. My hope is to continue your good work with an equal sense of commitment. Your generous offer to advise on any and all matters in the future is appreciated. You can be assured I shall continue the same close contact which we have maintained since the transfer of the Secretariat from Gainesville to Urbana in August.

On September 25 and 26, some two dozen Latin American Center Directors met in Washington, D.C. in the first of two meetings supported with a grant from the Rockefeller Foundation. They convened to discuss the present and future state of Latin American Studies and to plan the agenda for the second meeting to be held in February at Wingspread in Racine, Wisconsin with additional support from the Johnson Foundation. The Center directors were given the opportunity to meet with members of Washington-based agencies and members of the federal bureaucracy, including representatives from the International Communications Agency, the Department of State, the Office of Education, the House Committee

on International Relations, the President's Commission on Foreign Language and International Studies, the Organization of American States, the American Council on Education, the Inter-American Foundation, and the Inter-American Development Bank.

As a result of this first meeting, LASA has determined to take a more forceful role in stating its views on federal financing for international studies in the United States. Our President, Riordan Roett, and Vice-President, William Glade, along with the Chairperson of the CLASP Steering Committee, G. Micheal Riley, have written letters to the Secretary of HEW, Joseph Califano, members of Congress, and others, protesting present developments in the Office of Education which could lead to a substantial reduction of the present number of Foreign Language and Area Centers for all the world areas during the coming round of competition. If carried out, funds freed by this reduction would then be used to support problem-oriented or global educational centers. LASA's objections have stressed the need to maintain Title VI funding for Centers at the present level until the President's Commission has had an opportunity to hold its hearings and make its recommendations regarding this and other matters.

For the second meeting in February at Wingspread, these and other issues will be explored in several position papers on Latin American Studies. Again federal and foundation representatives will be invited. Officials of sister area associations will also be present.

Since March 31-April 1, 1979 marks the 15th anniversary of the military takeover in Brazil, Forums on Brazil are now being organized on many U.S. campuses. Those interested in the restoration of democracy in Brazil are asked to begin now to organize local

committees of students and professors to plan forums for the last week of March or the first week of April, 1979, and to encourage discussion of such topics as intellectual life, education, culture, industry, standard of living, urban quality of life, wages, etc., under 15 years of military rule. The Washington Office on Latin America (WOLA) has again offered to co-sponsor and coordinate Forums on Brazil. William E. Carter, Professor of Anthropology at the University of Florida and former director of the University's Center for Latin American Studies has been appointed Chief of the Hispanic Division, Research Service of the Library of Congress effective January 15, 1979. Presently serving as a member of the LASA Executive Council, Professor Carter is the fourth chief in the forty year history of that division.

## **BID SPECIFICATIONS FOR THE LATIN AMERICAN RESEARCH REVIEW**

The Latin American Research Review is scheduled to leave the University of North Carolina in 1982. The specifications which follow have been approved by the Executive Council. The present editor, John Martz, and Carl Deal at the LASA Secretariat will be pleased to respond to any questions.

### **I. Responsibilities.**

The responsibilities of the host institution will include:

1. Assuming the editorial direction of the LARR for the period 1 July 1982 to 1 July 1987.
2. Assuming the following associated functions: bookkeeping and accounting, subscription list maintenance, printing and reprints, mailing, advertising, etc..
3. Preparing a comprehensive statement on the editorial policy to be followed by the editorial staff.
4. Organizing, if judged appropriate, a consortium of institutions to carry out the responsibilities stated above.

### **II. Staffing.**

The editorial staffing arrangements will necessarily vary according to circumstances. On the basis of past experience, a desirable staff structure would appear to be as follows:

1. One-quarter to one-half time editor
2. One-quarter to one-half time associate editor
3. Full-time managing editor (funding supplied from LARR receipts as described below)
4. Full-time secretary
5. Two graduate assistants and/or work-study students

The Editor and Associate Editor should be scholars of recognized distinction.

The Association requests that all bidding institutions indicate by name, academic rank, and discipline the persons who will occupy the editorship and associate editorship. If possible, the institution should identify the managing editor and provide appropriate biographical and professional background material.

### **III. Funding.**

Current income from LARR generates funds for the salary of the managing editor, printing and production costs, mailing, telephone, office supplies and travel for the editors, as needed. Bidding institutions should specify the amount of release time to be given the editor and associate editor. The host institution should provide funds for secretarial and student assistance, as well as adequate office space, associated essential services, and a favorable rate for computer time.

### **IV. Documentation.**

Institutions bidding for LARR are requested to submit a document signed by university officials empowered to make the commitments involved, which document should contain or be accompanied by the following items of information:

1. Curriculum Vitae of the proposed editor and associate editor and, if available,

- appropriate biographical and professional materials about the managing editor.
2. A letter from each of the candidates for editor and associate editor indicating their willingness to assume the responsibilities involved.
  3. A list of Latin Americanists on the faculty of the host institution and other specialists with whom the editors might consult locally.
  4. A statement indicating the financial commitment the institution is willing to make towards the publication of LARR (e.g., secretarial and student assistance, overhead, etc.).
  5. A statement indicating how the actual printing and distribution of LARR will be handled (this need not be done through a university press).
  6. A brief description of the physical facilities which will house the LARR operation.
  7. Any other statements concerning policy or management of LARR which would be helpful to the Council in making its decision.

#### V. Editorial Advisory Board.

The Executive Council of LASA appoints, in consultation with the editors of LARR, an Editorial Advisory Board, with due regard for sex, disciplinary diversity, geographical spread and other considerations. The size of the Board is determined by the Executive Council. The term of office of the members of the Board is three years, once renewable. The Past President shall have an ex-officio seat on the Board. As appropriate, the Editorial Advisory Board will advise the editors on matters of editorial policy and will act, on request, as a review body for articles considered for publication in LARR. The Editorial Advisory Board may assist the editors of the Review in seeking out materials such as research reports, bibliographical contributions, and other items of scholarly interest.

Dr. John Grier Varner, 73, Professor Emeritus of English at the University of Texas, died of a heart attack on September 13, 1978. He joined the University faculty in 1947 and taught American literature courses until his retirement in 1972. He and his wife, Dr. Jeannette J. Varner, translated and edited "The Florida of the Inca," a prize-winning book first published in 1951. Garcilaso de la Vega's epic account of the De Soto expedition was written approximately 350 years ago and is considered the first great classic of American history. The translation became a History Book Club selection.

Varner also wrote "El Inca: The Life and Times of Garcilaso de la Vega," co-authored "Inglés Moderno," a Spanish-English grammar book, and edited "Edgar Allan Poe and the Philadelphia Saturday Courier." Varner was listed in the Directory of American Scholars and was a member of the Royal Academy of Sciences and Fine Arts in Córdoba, Spain. He taught at the University of Virginia from 1930 to 1938, and at Washington and Lee University from 1938 to 1943. He served in the U.S. Department of State from 1943 to 1947, working first as the executive director of the bi-national Cultural Center in Caracas, and then as a cultural attaché in the U.S. Embassy in Mexico City. He was a member of LASA for many years.

Professor García-Zamor:

After your announcement, last May, of the impending publication of Politics and Administration in Brazil, I wrote you asking that my paper on "Organizational Roles, Belief Systems and Military Politics" be eliminated from the reader. The reason for this was that the paper was produced in the early seventies, when you first contacted me asking for contributions. I saw it last May, as I see it now, as completely outdated and at variance with my present views on the subject.

You did not answer my letter and allowed the paper to be published without even an explanatory footnote. I do not know the reasons for your decision but I cannot help thinking of it as lack of respect for professional work.

Dear Professor Carvalho:

I have just received your letter of July 29. By now, you have probably received mine of August 1 where I explained to you that it was much too late to stop publication of your chapter in the book. When I received your first letter, the book was already at the press. I did, however, enquire with the publisher about the possibility of inserting a footnote, but even this was not possible.

I hope that the publication of this chapter will not embarrass you in any way. The long delay in getting the book published was very unfortunate. I found your chapter quite good, and I hope that the readers will be able to realize that it was completed in the early 70's. In your first letter you mentioned that your "views on the military have matured a little more and the military organization itself has changed together with the whole picture of Brazilian society." This was the consideration that concerned me the most since I would not like to publish something that could, in any way, be harmful to you. I deeply regret the fact that the chapter is "at variance with (your) present views on the subject." But as you can see by the size of the book, if I had tried to contact all the 18 contributors to ask them to update their chapters, the entire project would have been considerably delayed. You were the only one who felt so strongly that his chapter was out of date. This is obviously due to the political nature of the views expressed in it. I hope that you will accept my apologies.

On my next trip to Brazil I will try to contact you to explain to you again the circumstances that surrounded the publication of the book. In the meantime, I send you my very best wishes.

## RESEARCH

THE PROGRAM ON COMPARATIVE STUDIES OF IMMIGRATION AND ETHNICITY, sponsored by the Duke University Center of International Studies and the Department of Political Science and Sociology with support from the National Institute of Mental Health will appoint several post-doctoral fellows for the academic year 1979-1980. THE BRAZILIAN CHAMBER OF DEPUTIES under the Presidency of Deputado Marco Maciel has recently undertaken two significant Legislative studies research projects. The Parliamentary Profiles Series has selected 21 federal deputies from the Empire and Republican periods and commissioned individual studies by noted academicians in Brazil. Three studies have been published to date by the Center for Documentation and Information (CEDI), and 9 more will be completed by the end of 1978. The second endeavor involves a research agreement totalling \$40,000 signed with the University of Brasilia in December, 1978. This agreement provides for the compilation and publication of biographical and political career data for all federal deputies and alternates serving during the 1890-1937 and 1946-1967 periods. The resulting publications will thus complement their existing biographical reports for the 1967-79 period. In addition, this research project will examine the recruitment, selection and composition of the internal leadership structure of the Chamber of Deputies since 1890.

The AJIJIC INSTITUTE FOR INTERNATIONAL EDUCATION (IASEI) at the Universidad Autónoma de Guadalajara, Apartado Postal 1-440 Guadalajara, Jalisco, México, is conducting a study on higher education in Latin America. ### CONFERENCES

El Segundo Simposio del Proyecto Mexicano-Alemán de Puebla-Tlaxcala tuvo lugar en el Museo Nacional de Antropología del 2 al 7 de octubre de 1978. PERSPECTIVES ON SOCIAL, ECONOMIC, AND CULTURAL CONDITIONS IN CONTEMPORARY MEXICO was the theme of an international conference held in El Paso, Texas on September 13-14, 1978. The Chicano Studies Center, Center for Inter-American Studies, and the Institute of Oral History of the University of Texas at El Paso co-sponsored the event.

The 26th annual meeting of the AMERICAN SOCIETY FOR ETHNOHISTORY convened November 2-4 at the University of Texas at Austin. The meeting featured a special symposium honoring Dr. Wigberto Jimenez Moreno, who currently teaches at the University of the Americas and is affiliated with the Instituto Nacional de Antropología e Historia.

RECENT POLITICAL DEVELOPMENTS IN CENTRAL AMERICA: LINKAGES AND INTERDEPENDENCIES was the subject of a workshop held December 2, 1978 at New Mexico State University, Las Cruces, NM. The National Endowment for the Humanities awarded a grant of \$6,240 to CARLOS FERNÁNDEZ-CABALLERO and MARIANNE FERNÁNDEZ-CABALLERO for the compilation and preparation of Volumes III and IV of THE PARAGUAYAN BIBLIOGRAPHY. Volume III will be a continuation of Volumes I and II, i.e., a comprehensive listing of works published by Paraguayans and non-Paraguayans on the subject of Paraguay and by Paraguayans on any topic. 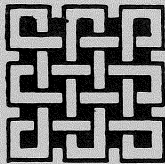
