## Nominations Invited for the 2019 Slate

*Deadline: September 15, 2018*

LASA members are invited to suggest nominees for vice president, treasurer and three members of the Executive Council for terms beginning June 1, 2019. Criteria for nomination include professional credentials and previous service to LASA. ## Guillermo O'Donnell Democracy Award and Lectureship

*Deadline: September 21, 2018*

The Latin American Studies Association is pleased to announce the establishment of the Guillermo O'Donnell Democracy Award and Lectureship to honor the distinguished career and pioneering intellectual leadership of the late Guillermo O'Donnell. This annual, Association-wide award and lectureship recognizes either outstanding scholarship in the field of democracy studies or particularly meritorious public service that promotes democracy and democratic values in Latin America and the Caribbean. The recipient is invited to give a keynote lecture at the LASA Congress at which the award is made.

In the case of academic recipients, the award and lectureship recognizes original research that is based at least in significant part on qualitative research methodologies that demonstrate the award recipient's personal familiarity with Latin America and the Caribbean. In the case of public figures, the award and lectureship gives international recognition to an individual who has made notable contributions to the advancement of democracy and the promotion of democratic values in her or his native country. Award and lectureship recipients need not be LASA members.

The Luciano Tomassini Latin American International Relations Book Award is presented at each LASA International Congress to the author(s) of an outstanding book on Latin American foreign policies and international relations published in English, Spanish, or Portuguese in any country. Books eligible for the 2019 award must have been published between July 1, 2017, and June 30, 2018. Anthologies of selections by several authors are not eligible. Books will be judged on originality of research, quality of analysis and writing, and the significance of their contribution to the study of Latin America and the Caribbean. Books may be nominated by authors, LASA members, or publishers.

Persons who nominate books are responsible for confirming the publication date and for forwarding one copy directly to each member of the Award Committee, at the expense of the authors or publishers. A nomination packet should include a statement justifying the nomination; a copy of the nominated book; and the complete mailing address, telephone and fax numbers, and e-mail address of the nominee. Packets should be sent directly to individual Award Committee members and to the LASA Secretariat by September 21, 2018. Nominations for the Luciano Tomassini Latin American International Relations Book Award can be submitted electronically. ### **Martin Diskin Dissertation Award**

*Deadline: September 21, 2018*

The Martin Diskin Dissertation Award is made possible through the generosity of Oxfam America, LASA, and LASA members. This award is offered at each LASA International Congress to an outstanding junior scholar who embodies Professor Diskin's commitment to the creative combination of activism and scholarship.

The award will be presented to an advanced doctoral student or recent Ph.D. All advanced Ph.D. candidates must demonstrate that they will complete their dissertation prior to the LASA International Congress. LASA limits recent Ph.D. recipients to those individuals who received their

degrees after the LASA Congress prior to the one at which the award is to be received. LASA welcomes dissertations written in English, Spanish, or Portuguese.

The Award Committee will evaluate three criteria: (1) overall scholarly credentials, based on the candidate's curriculum vitae; (2) the quality of the dissertation writing, research, and analysis as determined by the dissertation outline and sample chapter submitted; (3) the primary advisor's letter of recommendation. The definition of activist scholarship shall remain broad and pluralist, to be discussed and interpreted by each Selection Committee.

Applicants should submit a current curriculum vitae; a dissertation abstract of 250 words; the dissertation outline or table of contents; one sample chapter, which exemplifies the author's approach to activist scholarship; and a letter of recommendation from the candidate's primary advisor which focuses explicitly on the candidate's qualifications for the Martin Diskin Dissertation Award.

All application materials must be submitted electronically to the LASA Secretariat at [lasa.awards@pitt.edu](mailto:lasa.awards@pitt.edu) and received by September 21, 2018. The Martin Diskin Dissertation Award recipient will receive a \$1,000 stipend. LASA encourages wide distribution of this call for nominations to colleagues and students. ### **Howard F. Cline Book Prize in Mexican History**

### **Charles A. Hale Fellowship for Mexican History**

*Deadline: September 21, 2018*

This fellowship will reward excellence in historical research on Mexico at the dissertation level. It will be awarded at each LASA International Congress to a Mexican graduate student in the final phase of his or her doctoral research in Mexican history, broadly defined.

Selection will be based on scholarly merit and on the candidate's potential contribution to the advancement of humanist understanding between Mexico and its global neighbors.

### **Ford-LASA Special Projects - Thirteenth Cycle**

*Deadline: September 21, 2018*

LASA is pleased to announce the thirteenth cycle of the Ford-LASA Special Projects competition, made possible by a contribution by the Ford Foundation to the LASA Endowment Fund. Funds provided will support such activities as transregional research initiatives, conferences, working groups, the development of curriculum and teaching resources, and similar projects organized and carried out by LASA Sections or by ad hoc groups of LASA members.

Proposers are encouraged to think creatively about how this funding might be used to advance the principles of hemispheric collaboration among Latin American Studies scholars and teachers. Proposals that do not assign priority to this objective will not be considered for funding.

Proposals should identify the participants in the proposed activity, the objectives of the project, and the process by which those objectives are to be achieved. The total amount requested in each proposal may not exceed \$12,500. Grants may be combined with other sources of funding and may be used to initiate projects that continue with funding from other sources. No project or group will be funded more than once.

Proposals of no more than five (5) single-spaced pages in length must be received by the LASA Secretariat by September 15, 2018. Please send the proposals to [lasa@pitt.edu](mailto:lasa@pitt.edu). Proposals will be reviewed by a panel of LASA members appointed and chaired by the vice president of LASA for each program cycle.

Preference will be given to projects that involve transregional collaboration in the Western Hemisphere, and which are intended to result in publication of project results. It may be possible for LASA to disseminate project results, including conference papers, through its website, which would not preclude eventual publication in other media. Project directors are encouraged to consider submitting a panel proposal based on their preliminary work for presentation at the May 2019 LASA Congress. By June 30, 2019, the project directors will be required to submit a report on the activities undertaken with special project funding, suitable for publication in the LASA Forum. //
